## Dogs Eligible to Enter

This trial is open to all dogs over the age of 6 months that are registered with the American Kennel Club. Including ILP/PAL registration, AKC Canine Partners listing number, and Approved FSS breeds, except bitches in season, aggressive dogs or dogs suffering from any deformity, injury or illness, which may affect a dog's physical or mental performance. Refer to Chapter 1, Section 14 of the Obedience Regulations for further restrictions. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registrable breeds that may participate.

## Notice to Exhibitors

**ENTRIES CLOSE AT 6 P.M., WEDNESDAY, April 29, 2020 CDT** after which time entries cannot be accepted, cancelled, altered, or substituted. Changes, additions or corrections must be received in writing prior to close of entries. Those entries received by telephone are not acceptable.

**MAKE CHECKS PAYABLE to North Arkansas Kennel Club (NAKC) ALL ENTRIES MUST BE MAILED WITH FEES to Sherry Gibbany, 1483 Harding Blvd, Cotter, AR 72626.**

**RETURNED CHECKS** do not constitute a valid entry fee. The Trial Secretary will add \$25.00 fee to the amount of each returned check.

**ENTRIES WILL NOT BE ACCEPTED** without fees or signature. Entries not on Official AKC forms and photocopies of entry forms without the Agreement and Rules on the reverse side of the Official AKC entry form are not acceptable. No entry shall be made and no entry accepted which specifies any condition as to its acceptance.

**ENTRY FEE WILL NOT BE REFUNDED** for errors on entry blanks or for cancellation of entries after published closing date. **There will be no refund** in the event that a dog is absent, disqualified, excused by a Veterinarian or Judge, or barred from competition by the Event Committee. **Entry fees will not be refunded** if the trial cannot open or be completed by reason of riots, civil disturbances, fire, or act of God, public emergency, strikes or any other cause beyond the control of the North Arkansas Kennel Club.

**THE NORTH ARKANSAS KENNEL CLUB**, the Trial Secretary, Trial Chairperson, Event Committee, etc. assume no responsibility for the loss, damage, or injuries sustained by spectators, exhibitors, exhibitors' property and their dogs, and further assume no responsibility for injury to children.

**DOGS NEED TO BE PRESENT** for scheduled judging. Consult judging program for time of judging. **JUDGES NEED NOT WAIT FOR ANY DOG** holding up a class. Owners or agents alone are responsible for the presence of their dog in the ring.

**MOVE-UPS WILL BE ACCEPTED PER AKC Regulations.** Obedience and Rally Move-ups must be given to the Trial Secretary by 30 minutes before trial start time.

**JUMPS:** Please put the jump height on the obedience and/or rally entry (if your dog is entered in a class with jumps). On Saturday and Sunday rally jump heights will be set lowest to highest.

**ALL DOGS MUST BE ON LEASH OR CRATED** except when being judged.

**BITCHES IN SEASON** are not permitted in the trial. Entry fees for bitches that come into season after closing date will be refunded minus \$5.00 each trial entered. A written statement from a veterinarian must be provided on or before the day of the trial.

**THIS IS A NON-SMOKING FACILITY.**

**CHILDREN MUST BE SUPERVISED** by an adult at all times. **NO STROLLERS ALLOWED.**

Exhibitors should follow their veterinarians' recommendations to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations.

There will be no concessions but snack type foods will be provided and lunch will be provided.

#### Move-Ups

Move-ups will be allowed at this trial per AKC Obedience Regulations, Chapter 1, Section 16. Move-ups close one half hour prior to judging each day. Request must be in writing prior to the event. It is recommended that move-up requests be sent by email to the Trial Secretary prior to day of show. If an email address is provided with your request, an email confirmation will be sent.

## Directions to Show Site

**From the West:** Driving east from Harrison, AR on Hwy 62/412 E to Mountain Home: Upon entering into the outskirts of Mountain Home drive past the Sheid-Hopper Bypass, go straight through the stoplight on Hwy 62/412 E. Drive approximately 2 blocks; turn right on W. Wade Avenue for 0.3 miles. Turn right onto Fairgrounds Drive at the large sign.

**From the East:** Hwy 62/412 W to Mountain Home. Turn left onto Sheid Hopper Bypass/US62 HWY 412 W for 5.5 miles. Turn right onto Hwy 62. Turn right onto W. Wade for 0.3 miles. Turn right onto Fairgrounds Drive.

**From the North:** Hwy 201 S, turn right on 14<sup>th</sup> Street. It is about one block to Fairgrounds on the left. 14<sup>th</sup> St turns into W. Wade Ave.
