Sarah has been competing in dog events since the early 1990's with 5 Golden Retrievers and 6 Irish Setters. Sarah is accomplished in the conformation, obedience, rally, tracking, hunt tests, agility and scentwork. Sarah has competed with 3 dogs and have 72 element titles in both registries. Sarah is an AKC rally, novice obedience, temperament test and scentwork judge and a UKC judge in Rally, Obedience and nosework.

This is the only performance event that is one that can be trained mainly at home with very little cost of equipment and is a low impact sport available to any dog or handler. **This will be an introduction to all elements and how to get started and how to build practices designed for the beginner.**
