Including ILP/PAL registration, AKC Canine Partners listing number, and Approved FSS breeds, except bitches in season, aggressive dogs or dogs suffering from any deformity, injury or illness, which may affect a dog's physical or mental performance. Refer to Chapter 1, Section 14 of the Obedience Regulations for further restrictions. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registrable breeds that may participate.

**MAKE CHECKS PAYABLE to North Arkansas Kennel Club (NAKC) ALL ENTRIES MUST BE MAILED WITH FEES to Sherry Gibbany, 1483 Harding Blvd, Cotter, AR 72626.**

**RETURNED CHECKS** do not constitute a valid entry fee. The Trial Secretary will add \$25.00 fee to the amount of each returned check.

**ENTRIES WILL NOT BE ACCEPTED** without fees or signature. Entries not on Official AKC forms and photocopies of entry forms without the Agreement and Rules on the reverse side of the Official AKC entry form are not acceptable. No entry shall be made, and no entry accepted which specifies any condition as to its acceptance.

**MOVE-UPS WILL BE ACCEPTED PER AKC Regulations.** Obedience and Rally Move-ups must be given to the Trial Secretary by 30 minutes before trial start time.

**JUMPS:** Please put the jump height on the obedience and/or rally entry (if your dog is entered in a class with jumps). On Saturday and Sunday rally jump heights will be set lowest to highest.

**ALL DOGS MUST BE ON LEASH OR CRATED** except when being judged.

**BITCHES IN SEASON** are not permitted in the trial. Entry fees for bitches that come into season after closing date will be refunded minus \$5.00 per trial. A written statement from a veterinarian must be provided on or before the day of the trial.

**THIS IS A NON-SMOKING FACILITY.**

**CHILDREN MUST BE SUPERVISED** by an adult at all times. **NO STROLLERS ALLOWED.**

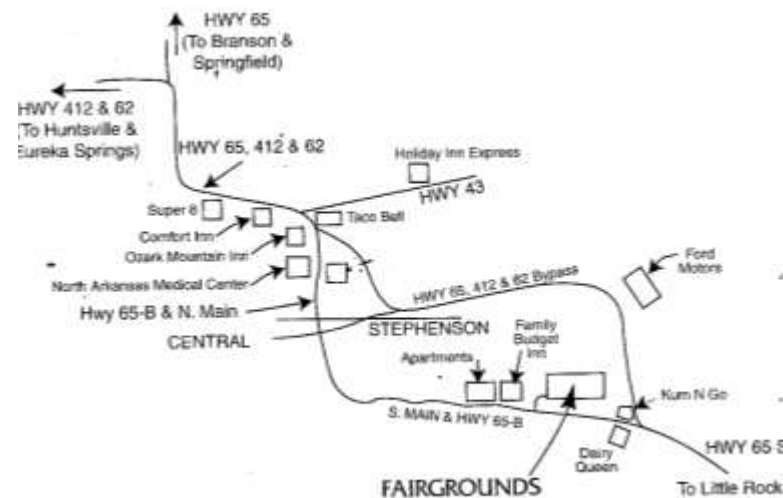
