ENTRY INFORMATION

Entries close on Friday, March 28, 2025 at 6:00 p.m., after which the entries cannot be accepted, canceled, altered or substituted, except as provided for in Chapter 11, Section 6 of the Rules Applying to Dog Shows.

All entries must be submitted on official AKC Agility entry forms, one dog per entry form.

Envelopes/transactions containing entries for more than the ten (10) dog maximum and/or entries received prior to the opening date shall be treated as an invalid entry and shall be returned to the sender.

DOGS ELIGIBLE TO ENTER

This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration. Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partner listing number, or approved Foundation Stock Service (FSS) Breeds are eligible to participate.

Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Wherever the word "dog" is used in these regulations it includes both sexes.

Dogs should be physically sound. Dogs that are blind shall not be eligible, and neither are bitches in season, aggressive dogs, or dogs suffering from any deformity, injury or illness which may affect the dog's physical or mental performance. No dogs shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registrable breeds that may participate. Puppies under four months of age are strictly prohibited from the trial grounds.

JUMP HEIGHT CARDS - NOTE NEW RULES EFFECTIVE 1/1/10

All dogs competing in agility must **possess** an official AKC Jump Height Card. An official AKC Jump Height Card is defined as either a permanent jump height card, a valid temporary jump height form, copies of two different measuring forms (placing the dog in the same height class) dated on or after the dog's second birthday, or copies of three different measuring forms (two of which place the dog in the same height class) on or after the dog's second birthday. All dogs **except those jumping 24**⁷⁷⁷ (unless a **VMO or AKC representative is present)** without permanent or temporary height cards must be measured. This measurement will only be valid for that weekend of trials only.

You are not required to show your height card or send a copy with your entry. You are required to mark on your entry form your dog's height card status. It is the exhibitor's responsibility to request measurement. If the dog does not have a valid Jump Height Card or form it must be measured by a VMO, AKC Field Representative or by the judge(s) of record before it runs and failure to do so will result in the cancellation of any qualifying scores.

New Simplified Jump Height Card Process

When filling out the entry form, there is a new section at the top of the form for exhibitors to designate whether your dog needs to be officially measured. Please check the appropriate box so that the Trial Secretary knows whether to include your dog on the Dogs To Be Measured List. It is no longer required that you submit a copy of your dog's jump height card with your entry form or show it during day of show check-in.

OBSTACLES AND RING CONDITIONS

Obstacles will meet the specifications for obstacles in the current edition of the Regulations for Agility Trials. All classes will take place indoors on dirt. Electronic Timers and rubberized contacts and table will be used.

SHOW SITE

Indoor arena with packed dirt floor. Site will be open for crate setup after 4:00 PM Thursday afternoon April 10, 2025. Building will not be available prior to 4 pm due to classes. Plenty of crate space is available. Crating near ring will be on dirt floor.

WAIT LIST INFORMATION

NAKC is offering a wait list to fill openings created by withdrawn entries after the trial's closing date/time. A maximum of 15 entries will be placed on the club's wait list. All entries, including wait listed entries, must be received by March 28, 2025 at 6:00 PM will be replaced by a wait listed entry if any are available. If a withdrawn entry is replaced by a wait listed entry, a full refund will be issued for the withdrawn entry. Any wait listed entry that does not move off the wait list into the trail by April 7, 2025 at 6 PM will receive a full refund.

MOVE-UPS

Move-ups will be accepted prior to start of trial until 6:00 PM on Monday, April 7, 2025. Mail or email pre-trial move-ups to sherrygibbany57@gmail.com. Day to day move-ups will also be accepted.

Dogs shall be moved up to a higher class at the request of the owner, as a result of the dog qualifying for an agility title. The request for a day-to-day move up must be made to the Trial Secretary not later than the day preceding the event. All move-up entries are subject to availability of the class and payment of any difference in entry fee. It is the option of the club to allow move-ups. Dogs so moved-up will be entered at the end of the running order. Refer to Chapter 1, Section 20 of the Regulations for Agility Trials for additional move-up requirements.

Move-up forms will be available at the Secretary's table for these trials.

WARM-UPS

Handlers in all classes are permitted to walk the course, without a dog, prior to the start of the class. The walk through period allows handlers to plan their strategy running the course and will be held prior to each class, following the judge's briefing. A warm-up area, consisting of a regulation agility jump, shall be provided. The walk through is restricted to handlers entered in that class only. Handlers with multiple dogs, at events with multiple rings may request to walk with a height group other than the one their dog is entered in if a conflict is imminent.

RIBBONS AND PRIZES

Ribbons will be awarded to the 1st through 4st place teams in each jump height in each titling class. Dogs must qualify to receive ribbons. Qualifying ribbons will be awarded to all dogs receiving qualifying scores in each titling class. New title rosettes will be awarded to all dog/handler teams finishing a title. Double Q and triple Q ribbons will be awarded to all dogs qualifying in both Master Standard and Master JWW in the same trial. Dogs earning a new MACH or PACH title will be awarded a bar and rosette.

EXHIBITOR INFORMATION

- 1. The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.
- All dogs must be on leash or crated at all times except when in the ring or when in the designated agility warm-up area.
- Puppies under the age of 6 months are prohibited from the show grounds according to AKC regulations.
- Exhibitors are responsible for picking up after their own dogs. Plenty of space is available for exercising your dogs.
- 5. Smoking inside the building is strictly prohibited.
- 6. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused or barred from competition by action of the Event Committee, Veterinarian or judge.
- 7. Bitches in season are not permitted in the trial.
- 8. Bitches in season or injured dogs or handlers will have all but \$5.00/day of the entry fee refunded if unable to compete for that reason. The Trial Secretary must receive <u>written notification from a Veterinarian</u> of such claim before judging commences on April 12, 2024 e shall have any claim or recourse against NAKC or any official thereof.
- 11. Unsportsmanlike conduct, including rough handling, disrespect of match workers or others, or misconduct of any kind, will result in refusal of entries, or excusal from the show site. NAKC reserves the right to decline entries or remove any dog from this event for cause.
- 12. The North Arkansas Kennel Club, Inc. and the University of Arkansas assume no responsibility for any loss, damage, or injuries sustained by exhibitors, handlers, their dogs or property and further assume no responsibility for injury to children.
- 13. YOU are responsible for any damage you or your dog do on the show site. A Trial Committee will be convened for cause.
- 14. On-site concessions will NOT be available at this trial. There are several fast food places nearby. On-site food truck will be available Friday and Saturday (JF Eatery)
- 15. Please keep the show site clean.
- 16. Exhibitors are responsible for complete, accurate, and legible information on their entry forms: illegible or incomplete entries cannot be entered in the show. IF THE ENTER FORM IS PHOTOCOPIED, THE AGREEMENT ON THE BACK OF THE FORM MUST ALSO BE PHOTOCOPIED AND ATTACHED TO THE ENTRY WHEN IT IS MAILED. Unsigned Entry Forms cannot be accepted as well as entries which specify any conditions as to its acceptance. Changes, Additions or Corrections to entry forms MUST be received in writing prior to close of entries. Those received by telephone are NOT acceptable.
- 17. Paper entries received within the first 24 hours must include postage or be metered. Entries must be delivered by multi-state or multi-national postal or carrier service, including but not limited to USPS, FedEx, UPS and DHL.
- 18. No refunds for duplicate entries. However, care will be taken to find duplicates before processing. Owners are responsible for errors in making out entry forms and no entry fee will be refunded in the event of such errors.
- 19. Checks that have been returned due to insufficient funds do not constitute a valid entry and will have a \$25.00 service charge attached. Subsequent returned checks from the same exhibitor may result in their being put on a CASH ONLY BASIS.
- 20. No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.
- 21. NO CRATING in the first two rows of all bleachers and where indicated "NO CRATING". Classroom crating is for committee members only. Crating will take place in the arena very limited crating in the lobby.

- 22. Exhibitors may choose to enter their dog in a higher height division than required by AKC but not a division lower than their AKC mandated height.
- 23. Electronic Timers will be used.
- 24. The trial will be held indoors on two 90' x 92' packed dirt surfaces.
- 25. The trial will be run under the revised Regulations for Agility Trials that became effective as of January 1, 2022.
 - Running Order The running order for trial could change prior to the trial to help with limitations in the total number of exhibitors allowed in building. The club will do its best to keep exhibitors informed before closing date.
 - Leash There will be a leash runner or an exhibitor may run with their leash in their pocket or clipped around their waist.
 - Course Maps The club will make every effort to get course maps posted on the Agility Gate App and also emailed to exhibitors by 7 am the morning of each trial per AKC regulations.
 - Changes to Rules Please check your confirmation letter to see if any changes have been instated whether by the club or University of Arkansas. Please be aware that infarctions of these rules will be dealt with according to AKC regulations up to and including requiring you to leave the trial site and bench committee hearings.
 - Entering Building Exhibitors may not enter building until the designated time given with
 final confirmation or they are subject to being excused from the trial and no refund given.
 This includes entering lobby prior to setup time on Thursday afternoon/evening as we
 must respect the University and the classes taking place.

Effective January 1, 2020, exhibitors may enter a mixture of both Regular and Preferred classes on the same trial day and /or during the trial weekend.

Any mixture of Regular and Preferred classes is allowed. If a dog qualifies in Regular Master STD and Preferred Master JWW (or vice versa) on the same trial day, no double Q shall be earned toward either the MACH or PACH title. A double Q requires that qualifying runs be both in Regular or both in Preferred on the same trial day.

Also, within the same Regular or Preferred classes, a dog may now be entered in multiple jump heights within the same trial day. For example, the same dog may now be entered in 20 inch Master STD/JWW and entered in 24C Premier STD/JWW on the same trial day.

Separate entry forms must be submitted for Regular classes and Preferred classes, or for different jump heights entered in the same weekend. When calculating entry fees, treat multiple entry forms for the same dog as if only one form had been filled out. In other words, the first run entry fee is only paid once per day, per dog, even if that dog's runs have been submitted on multiple entry forms.

Effective January 1, 2022, For Exhibition Only (FEO) and Fix and Go On are permanent components of the AKC agility program with FEO being update July 2024 as follows:

FEO may be offered ata the option of the host club. FEO will allow exhibitors to work with their dogs in a trial environment. FEO is allowed in all classes. Participation in FEO in non-qualifying. Toys are allowed in the ring. Toys must be non-audible and may not leave the handlers hand. Toys that roll freely may not be used. Food and treats are not allowed in the ring. Harsh verbal and/or physical corrections will not be tolerated. Dogs may be entered at any jump height for FEO. If entered in ineligible jump height, the team is committed to FEO for that run and must declare FEO on the start line. Day of show jump height changes are not allowed. Dogs may be entered at any level (Novice, Open, Excellent or Masters) in FAST, JWW, STD or Premier classes. If the dog is not eligible for the level entered, the team is committed to FEO for that run and must declare FEO on the start line. Day of show level changes are not allowed. FEO does not need to be noted on the entry form/ the handler will declare the day of the trial. Must declare in ring prior to leading out to scribe and the judge. FEO runs are treated as trial entries. The exhibitor must enter the class(es) prior to closing date, pay class entry fee(s). Course time for FEO in T2B, JWW, STD, and Premier will be 45 seconds. FAST course times for each class/height are as noted in the Regulations.

Fix and Go On allows exhibitors to immediately reattempt an obstacle at any time while on course when the dog's performance of an obstacle is not to their expectation. This allows the dog to successfully complete the obstacle then finish the course or leave the ring on a positive note. Using Fix and Go On will result in a non-qualifying score. Fix and Go On is not pre-entered; rather, it occurs during the run.

MOTEL AND RV INFORMATION

Please pick up after your dogs so that these motels will continue to accept dogs. Some restrictions may apply. Check with motels regarding rates and dog policy when making reservations. The entire motel and grounds are considered part of the trial grounds. Any damages to your room may be subject to disciplinary action in accordance with the rules of the AKC. 

All dogs that have not been officially measured for an **Agility Jump Height Card** may still compete; however, they must be measured by *a* Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, hat measurement will be valid for this trial or back-to-back trials only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the AKC Canine PartnersSM program may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

Junior Handlers should enter their Junior Handler number on the front of this form. Should you not have your Junior Handler number,
may be obtained from the American Kennel Club (919) 233-9767. If the Junior Handler is not the owner of the dog identified on the face
