It is recommended that transfer requests be sent by email to the Trial Secretary prior to the day of the show. If an email address is provided with your request, an email confirmation will be sent.

ENTRY FEES

The Trial Committee may require that the crate of any dog creating a disturbance in the crating area, through lunging, barking, growling, or other actions, be covered with opaque material. Trial Committee members may rearrange crates to maximize space if needed, including restricting placement of chairs in the crating area. Please crate in the specified areas. Your co-operation is appreciated.

ENTRIES CLOSE AT 6 P.M., FRIDAY, May 1, 2026 CDT, after which time entries cannot be accepted, cancelled, altered, or substituted. Changes, additions, or corrections must be received in writing prior to close of entries. Those entries received by telephone are not acceptable.

MAKE CHECKS PAYABLE to North Arkansas Kennel Club (NAKC). ALL ENTRIES MUST BE MAILED WITH FEES to **Sherry Gibbany, 158 Bland St, Cotter, AR 72626.**

RETURNED CHECKS do not constitute a valid entry fee. The Trial Secretary will add \$25.00 fee to the amount of each returned check.

ENTRIES WILL NOT BE ACCEPTED without fees or a signature. Entries not on Official AKC forms and photocopies of entry forms without the Agreement and Rules on the reverse side of the Official AKC entry form are not acceptable. No entry shall be made, and no entry accepted which specifies any condition as to its acceptance.

ENTRY FEE WILL NOT BE REFUNDED for errors on entry blanks or for cancellation of entries after published closing date. **There will be no refund** in the event that a dog is absent, disqualified, excused by a veterinarian or Judge, or barred from competition by the Event Committee. **Entry fees will not be refunded** if the trial cannot open or be completed by reason of riots, civil disturbances, fire, or act of God, public emergency, strikes or any other cause beyond the control of the North Arkansas Kennel Club.

THE NORTH ARKANSAS KENNEL CLUB, the Trial Secretary, Trial Chairperson, Event Committee, etc. assume no responsibility for the loss, damage, or injuries sustained by spectators, exhibitors, exhibitors' property and their dogs, and further assume no responsibility for injury to children.

DOGS NEED TO BE PRESENT for scheduled judging. Consult judging program for time of judging. **JUDGES NEED NOT WAIT FOR ANY DOG** holding up a class. Owners or agents alone are responsible for the presence of their dog in the ring.

TRANSFERS WILL BE ACCEPTED PER AKC Regulations. Obedience and Rally Transfers must be given to the Trial Secretary by 30 minutes before trial start time.

JUMPS: Please put the jump height on the obedience and/or rally entry (if your dog is entered in a class with jumps). On Friday, Saturday, and Sunday, rally jump heights will be set from lowest to highest.

ALL DOGS MUST BE ON LEASH OR CRATED except when being judged.

BITCHES IN SEASON are not permitted in the trial. Entry fees for bitches that come into season after closing date will be refunded the full entry fee. A written statement from a veterinarian must be provided on or before the day of the trial.

THIS IS A NON-SMOKING FACILITY, which includes vaping.

CHILDREN MUST BE SUPERVISED by an adult at all times. **NO STROLLERS ALLOWED.**

NO EX-PENS ALLOWED.

Exhibitors should follow their veterinarians' recommendations to ensure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

WAITLIST AND REFUND POLICY

North Arkansas Kennel Club is offering a waitlist for rally entries, which will automatically close when limits have been reached, even if it occurs before the official closing date.

A wait list will be maintained in the event the limit is reached in any trial. If there are any entries withdrawn prior to the closing date, the next entry on the list shall be contacted.

Entries that are withdrawn prior to closing shall be reimbursed in full.

All entries, including wait-listed entries, must be received by the Trial Secretary prior to Friday, May 1, 2026 at 6:00 pm. No entries may be withdrawn with a refund after closing on Friday, May 1, 2026 at 6:00 pm. If a withdrawn entry is replaced by a wait-listed entry, a full refund will be issued for the withdrawn entry. Any wait-listed entry that does not move off the wait list into the trial will receive a full refund for the wait-listed entries. Waitlisted entries will have until Friday, May 8, 2026, 6:00 pm to move off the wait list.
